

**GENERAL POLICIES**

***How to Apply***

***To determine if your child (or children) qualifies for a scholarship in the Puyallup Parks and Recreation Programs, follow the instructions listed below.***

- \* *Read through the General Guidelines information contained on this page.*
- \* *Using your family income from all sources, enter that amount on the application on the back.*
- \* *Funding will be available at a percentage, depending on the family gross yearly income.*
- \* *Fill out the application form on the reverse side of this brochure and turn it into the Puyallup Recreation Center office, at 808 Valley Avenue NW. Your registration will be processed according to the Financial Assistance Guidelines. If co-payment is required, then it must be paid at time of registration.*

1. The applicant must qualify under the Family Income Guidelines. The Family Income Guidelines will be determined by the following:
  - a. The Department of Social and Health Services current “Family Income Standard of Need” will be used as the basis for establishing the Family Income Guidelines.
  - b. Funding will be available at a percentage, depending on the family gross monthly income.
  - c. Verification of income must be attached in order to process this application.
2. If a participant receives partial funding, then he/she will be required to pay the difference in the youth sports registration fee prior to participation.
3. Funds will only be used for Puyallup Parks & Recreation sponsored programs.
4. Applicants must attend Puyallup Schools and live within the school district boundaries to be considered for a youth sports scholarship.
