Applicant shall not deviate from the purpose stated above for hydrant use. Applicant shall be required to install a metering device. Applicant shall not connect to any pipes, hoses, or tanks that are not visible to inspections by agents of the City of Puyallup Water Division. Applicant shall be held responsible for any damage to the public water system caused by improper operation of a hydrant. Applicant shall not establish any cross-connection to a hydrant. A City approved Reduced Pressure Backflow Assembly (RPBA) or air gap shall be installed and maintained by the person requesting use of a fire hydrant. The assembly shall be accompanied by a current backflow assembly test report. The test report shall be available at the site for the duration of the hydrant use.

Any improper use of a hydrant will result in immediate and permanent discontinuation of hydrant privileges, non-release of the deposit and may include the initiation of legal action.
